Oneontawood LLC TMP#300.11-1-22.02; 762 St Hwy 28 Site Plan Review Application PB000452

Mike O'Reilly and Dan O'Reilly of Principle Design Engineering PLLC appeared to represent Oneontawood LLC application for Site Plan Review to expand the current asphalt area to add additional parking spaces. Project consists of 7 parking spaces in the rear and 2 on the side, with a 9' tall by 152' retaining wall made out of precast Redi-Rock blocks. Additional parking spaces are needed for a prospective tenant (car rental company). Board expressed concern due to the

tightness of the area. Applicant/Owner are trying to improve the existing conditions. All agreed that the existing 16' lane is tight and that they will be increasing it to 18'. Parking spaces shown are 9 x18 and need to verify if variance required for parking spaces and/or setback requirements. After discussion, it was decided that guard rails would be preferred to parking stops and a one way traffic sign needs to be installed. Decision was tabled until the next meeting, so that the Oneonta Fire Department can be contacted and prior approvals can be pulled.
