Pedestrian entrance will be on the left of front building and roped off aside from handicap vehicles. He is proposing 12x12 spots for vendors, a possible food truck and 2 porta johns, with a handicap bathroom available inside the business. While not enough parking provided per the Town Code 103-50 for the proposed site plan, applicant agreed to have the business closed during hours of the flea market and advised vendors would be parking within their space, not in the parking noted on site drawing. Board agreed to give approval for 2 of the 3 proposed buildings (building 1 & 2 noted on site drawing) without sending him to the Zoning Board of Appeals for a parking variance, so he could get started and see how it goes before going to any additional expense.
