Special Use Permit Application PB000475

Al Hinkley of Network Building & Consulting (agent for Verizon Wireless) appeared to represent the Special Use Permit Application for a cell tower modification, removing 9 panels, 3 remote radio units and one OVP, and installing 6 new panels, 6 remote radio units, 6 combiners, and one OVP on the existing tower. The installation will not increase the height of the tower or the dimensions of the equipment compound and will enhance wireless communications services to the community with new technology. Board questioned the life of the tower and the deficiencies noted on the Structural Analysis, but acknowledged passed inspection. Mr. Hinkley advised board that the tower and maintenance were the responsibility of the tower owner (American Tower), not the carrier. Communication towers are federally regulated. Therefore, since there is no substantial change to the physical dimensions of such tower or base station, applicant would like to request a waiver be granted and released to the building department for a permit.

**Motion** made by Kirt Mykytyn and seconded by Reggie McGuinness that the Special Use Permit Application will not have a negative impact on the environment.
