## "Privilege of the floor"

- Eileen Lishansky, West Oneonta resident, raised concerns about unlicensed dogs in her neighborhood, an unresponsive dog control officer, and excessive dog barking. The board agreed to look into the matter.
- Caroline Willims, SUNY Oneonta, highlighted Local Government training available through the NYS Dept. of State.
- Arley Lau, asked if the board had any new information concerning short term rental (STR) legislation which the board had considered in the past. Member Holleran spoke of the work towards new forms for STRs; as well as, having attended meetings with other municipalities regarding the topic, and finding that our town was still ahead of many other municipalities regarding regulation of STRs.

Fierke stated the board will be forming a committee composed of town residents, town and planning board members focused on the code and how it affects the community at large. Fierke made clear that all aspects are to be considered; from those seeking use of STRs as income properties, those wanting to preserve the integrity of their neighborhoods, and concerns about the existence of long-term family housing stock in the town.

Hollern cited that New York State, as of Dec. 2024; had implemented a mandate for the collection of sales tax from STRs, and thus the creation of a registry at the county level, potentially changing STRs classification and how they operate and handled within the town code. Little real guidance has been given by the state as how to implement some of the required changes, Holleran states, as talks are underway with the county and research is ongoing.

• Eugene Molinari, Woodland Water District resident; remarked on the prolonged periods of discolored water requiring continuous flushing, and if the board had considered an adjustment to the water bills. Board members agreed to look into the financials of the district and see if some relief is possible, as districts must remain financially sound as to avoid potential increases in the future. Holleran expressed that the board is very sympathetic to the plight of the residents in the water district and are doing everything within their power to solve the issue, as 4.2 million in grant funding has been secured to start the process of replacement of the aged infrastructure.

Alberto J.F. Cardelle, SUNY President presented the board with the SUNY Oneonta Annual Update

- Discussed enrollment trends and diversification efforts made by the University.
- Workforce development programs and initiatives to increase graduate enrollment were highlighted.
- SUNY Oneonta expressed a commitment to collaboration with municipalities to benefit the community.
- Discussed SUNY Oneonta's Extended and Community Learning Center (ExCL Center) located in downtown Oneonta on Dietz Street.

The board had two new zoning amendment applicants each making presentations before the board:

1. Tirusha Dave & Prashanth Gorantala with EcoYotta, Inc.; seeking a zone change for parcel#298.00-2-15.02, 357 County Highway 9, from RA40 to IDD, to develop a "Data Center" at the property. Member Riddell Kent asked if the applicants had considered utilizing one of

the towns currently existing industrial zones for the project instead of a residential/agricultural zoned parcel. James Hurtubise, owner of a neighboring parcel was opposed to the idea.

2. Jamie & John Parks with Hillside Rentals, LLC; seeking a zone change for parcel#301.07-2-61.00, 157 County Highway 47, from RA40 to PDD, to develop the property for short term housing.

In both cases the board has asked for more documentation to be presented before a decision to set a public hearing is made.

## RESOLUTION 2025-0068 SCHEDULING PUBLIC HEARING PERTAINING TO THE PROPOSED FORMATION OF THE TOWN OF ONENONTA WEST END WATER DISTRICT PURSUANT TO ARTICLE 12-A, SECTION 209-d OF THE TOWN LAW OF THE STATE OF NEW YORK

WHEREAS, the Town Board for the Town of Oneonta, is considering the formation of a water district in the Town of Oneonta to be known as the West End Water District; and

WHEREAS, the Town Board believes it in the best interest of the citizens of the Town to form a water district, said proposed water distribution system to include the areas described in Schedule A attached hereto and made a part hereof; and

WHEREAS, to further consider a proposed water district to be known as the West End Water District, and pursuant to Article 12-A of the Town Law of the State of New York, the Town Board, directed C&S Engineers Inc. of 499 Col. Eileen Collins Blvd, Syracuse, New York 13212, to prepare a Map, Plan and Report of the proposed water district; and

WHEREAS, said Map, Plan and Report was filed with the Town Clerk for the Town of Oneonta the May 12<sup>th</sup>, 2025, entitled West End Water District, Map, Plan and Report, October 2024; and

WHEREAS, this Board has reviewed the Map, Plan and Report, and wishes to schedule a public hearing regarding the possible formation of a water improvement district to be known as the West End Water District pursuant to Article 12-A Section 209-d of the Town Law of the State of New York.

NOW, THEREFORE, on motion made by Council Member Patricia Riddell Kent, and seconded by Council Member Jospeh M. Camarata, BE IT RESOLVED as follows:

1. That this Board will hold a Public Hearing pursuant to Section 209-d of the Town Law of the State of New York on the 11th day of June, 2025 at 7 p.m. at the Town Hall, 3966 State Highway 23, West Oneonta, NY 13861 to consider the formation of a water district to be known as the West End Water District, and directs that notice of same be given pursuant to law.

2. That pertaining to the proposed water district, the Town Board does hereby find as follows:

a. A description of the boundaries of the proposed water district is more particularly set forth in Schedule A attached hereto and made a part hereof.

b. The improvements proposed would be as follows:

The City of Oneonta has an established water system serving the proposed West End Water District. The West End Water District will continue to utilize the existing facilities in the Town of Oneonta. The existing facilities are as follows:

- Seven (7) interconnections with the City water system;
- Ninety-Seven (97) fire hydrants;
- Two hundred and Twenty-Six (226) main line valves;
- 37,580 linear feet of existing 6" (CIP and DIP) water main;
- 21,042 linear feet of existing 8" (CIP and DIP) water main;
- 1,214 linear feet of existing 10" (CIP and DIP) water main;
- 11,120 linear feet of existing 12" (CIP and DIP) water main;
- Six Hundred and Fifty-Six (656) water services; and
- One (1) 500,000-gallon water tank.

d. Financing for the proposed project is not necessary as the district will utilize existing facilities. There are no new facilities planned to be constructed at this time. As a result, there is no new capital cost associated with the proposed West End District.

The resulting initial annual unit charge is estimated to be \$556.23 per equivalent dwelling unit (EDU). This charge represents the total annual cost to a typical single-family household, inclusive of water purchase.

e. The Map, Plan and Report describing such improvements as prepared C&S Engineers Inc., and filed in the Town Clerk's Office of the Town of Oneonta, is available for public inspection.

3. That the Town Clerk of the Town of Oneonta is hereby authorized and directed to publish a copy of this Resolution/Order in the Daily Star, the official newspaper for the Town of Oneonta, and to post a copy of same on the official bulletin board for the Town of Oneonta in the time and manner required by law.
