Discussion:

Councilwoman Riddell Kent requested that instead of voting for the full slate, she would like to discuss and vote on item Letter H Member of the Zoning Board of Appeals separately. She went on to say the ZBA is an Appellate body requiring training and a full command of the Zoning Code and needs someone who can understand the process. Ken Pym who has served for 4 years is willing to serve again. He is trained, knowledgeable, and an independent thinker and he's done a good job. Riddell Kent said,

"I don't know Allen Black?" She suggested the board might want to meet with both men to make a more informed decision.

Supervisor Mowers stated a motion stood for a vote on the block in its entirety.

Councilman Holleran stated, with regards to appointee selection, [it] has been at the discretion of the Supervisor.

Council Member Fierke suggested exploring a selection process for future Board appointment nominations.

Councilwoman Riddell Kent stated she was voting 'NO', based on (Letter H), Allen Black, for Member of the Zoning Board of Appeals. She would like Ken Pym to be renewed.

New Year's Day, Martin Luther King Day (observed), Federal Presidential Holiday in February (observed), Memorial Day, Juneteenth, Independence Day, Labor Day, Columbus Day, Veterans Day Thanksgiving Day and the Friday immediately following Thanksgiving Day and Christmas Day.

- a. The Highway Department shall observe Good Friday in lieu of Martin Luther King's birthday and individual birthdays of employees in lieu of Veterans Day. Any of the designated holidays/birthdays falling on a Saturday shall be observed on the Friday immediately preceding the Saturday holiday; holidays falling on a Sunday shall be observed on the Monday following the holiday.
- ❖ Resolution to authorize Randal I. Mowers to enter into and execute funds, transfers and/or ACH agreements at Community Bank, Bank of Cooperstown and NYCLASS.
- ❖ Resolution authorizing Supervisor to submit to the Town Clerk a copy of his/her Annual Report to the State Comptroller and directing the Town Clerk to cause a notice to be published within ten (10) days after receipt of said report in the official newspaper of the Town that a copy of such report is on file and available for inspection in the Town Clerk's office.
