PB000498 DTC Cable TMP#300.00-3-38.00; 1040 Swart Hollow Road

Special Use Permit Application PB000498

Ken Prestidge (Project Manager) and Jason Woodyshek (Engineer) appeared to represent the DTC Cable Special Use Permit Application to install a 12'x20' aggregate building on a 12'x32' concrete slab for television, telephone and internet service to the area. Parcel is located in a RA40 zoning district; therefore a Special Use Permit would be required. Applicants are looking at an easement with the property owner Janice Smith, which could turn into a purchase. They are in the process of having a survey performed to be sure setback requirements are met or if they would need to reduce the size of the building to 10 feet wide, seek a lot line adjustment or an area variance. Building houses a switch, fiber cross connects and batteries, with a backup generator on outside slab. There will be no occupancy of the structure (no water or sewer). One or two people may be in the building once or twice a day, if there is service trouble or adding a new customer. Building will service activity in the South on State Highway 28, but future growth a possibility. Currently they have one of these buildings in Franklin and are in the process of putting them in Davenport Center, Fergusonville, and Worcester. The Town may be seeking a 20 foot wide easement on this property for the proposed Southside Water District, but applicant stated that wouldn't be a problem as it would be in the parking area. Applicant advised he would contact the Code Office and drop off the survey as soon as completed.
