### **COMMITTEE REPORTS**

<u>Highway/Water & Sewer</u> – Motion was made by Riddell Kent to authorize the highway superintendent to attend conference Sept 17 - 20, 2019. Seconded by Mowers.

VOTE- Ayes- 5, Nays 0 Motion carried

Motion was made by Riddell Kent to surplus the 3-point hitch finish mower. Seconded by Mowers. Mowers stated that the mower is not being used.

<u>Public Safety</u>- Motion was made by Holleran to authorize the purchase of portable radios for the constable. Seconded by Riddell Kent.

<u>Facilities</u>, <u>Technology</u>, <u>Parks</u> - Repairs to the pool totaled \$21,000. Hurtubise stated that the pool is working excellent.

Molly Swain expressed concern over people speeding through the Plains. Molly asked why sidewalks cannot be put in. Wood stated they are expensive. Jacob stated that it could be brought up at the homeowners association. There was discussion of another lane or possibility of a loop being put in.

<u>Human Resources and Public Benefit</u> – The board discussed that the starting salary for the new town court clerk would be 13.90-15.00 per hr. based on experience. If someone with significantly better experience applies the board would consider going above this amount.

<u>Legislative</u> –Motion made by Holleran to set a Public hearing is set for September 11, 2019 at 7:00PM on the change to the zoning code for non-conforming uses. Seconded by Jacob.
