A regular meeting of the Oneonta Town Board was held on January 13, 2021 via Zoom with the following members present:

PUBLIC HEARING-CDBG project 848PW39-14

Motion was made by Riddell Kent to open the public hearing for CDBG project 848PW39-14, Southside Water at 7:00PM. Seconded by Mowers. Town resident Jon Anderson asked what the public hearing was about. Supervisor Wood explained that it was a requirement because we received a \$600,000 community development block grant which is a HUD program. No one was present to speak about the public hearing. Motion was made by Riddell Kent to close the public hearing. Seconded by Mowers.

PUBLIC HEARING- CDBG project 848ED916-18

Motion was made by Jacob to open the Public Hearing for CDBG project 848ED916-18, Custom Electronics at 7:15PM. Seconded by Riddell Kent. Jody Zakrevsky from Otsego Now stated that he appreciates the Town of Oneonta working with them to get the grant. This was the first CDBG that has been awarded in a long time. Jody acknowledged Attorney Panasci in being instrumental in working on agreements. They spent the entire grant and 50 jobs were created. He also thanked the town board for being tremendous on working with them. No one else addressed the board. Motion was made by Mowers to close the public hearing. Seconded by Jacob.

Motion was made by Mowers to approve Change Order for McCarthy Electric. Seconded by Riddell Kent. Supervisor Wood stated that this was proposed at the last meeting. The rest of the items on the change order were acceptable. Highway Superintendent Hurtubise and Supervisor Wood met with Brendon Becker from Lamont. Lamont Engineers will pick up the cost of the moving of the wiring and the lights in the closet. We will receive a credit on our bill for that portion of the change order.

Highway Superintendent Hurtubise stated that he got 3 quotes on equipment trailers. It's a trailer that could be pulled behind the pickup or the 1 ton. It is a 16,000 pound trailer with a tilt bed. It will work ideally for the roller and the new skid steer. Supervisor Hurtubise got two prices for a PJ Brand Trailer and one was for a Cam Superline Trailer. The PJ trailer is a heavy duty equipment trailer through Roy Teitsworth Trailers out of Rochester. The price came in at \$8302.50. \$600 cheaper than the second quote. It meets all the criteria we are looking for. Motion was made by Jacob to approve the purchase of a PJ Trailer. Seconded by Mowers.

Town of Oneonta Resolution for the Aged STAR Exemption

Whereas the Governor of the State of New York has issued an Executive Order regarding renewals for Aged STAR for those earning less than \$26,000 a year.

Whereas cases of COVID-19 have been increasing dramatically in the Town of Oneonta and the County of Otsego over the last few weeks.

Whereas it has been shown that elderly persons are at risk should they contract the virus.

Whereas the town hall in the Town of Oneonta is a public building.

Whereas residents who qualify for the Aged Star visit the Assessor at the town hall annually to verify their income.

Whereas residents who are retired are generally on a fixed income which does not change from year to year.

Therefore, for the year 2021, the Town Board of the Town of Oneonta, grants permission to the Town of Oneonta Assessor to automatically renew the Aged Star Exemption for those who qualify under the Executive Order.

Motion was made by Riddell Kent to approve the Town Clerk Record of Activities and to submit the report to the State. Seconded by Holleran.
